Graduation Rates

As of July 1, 2022, the graduation rate for students who began their post-secondary training at our school from September 1, 2019, through August 31, 2020, and for whom 150 percent of the normal time for program completion elapsed as of August 31, 2022, is presented in the following calculations:

Of the **354** students who began school, **0** students were qualified for an exclusion from the cohort. Of the **354** students, **288** completed their coursework and graduated within the allowed timeframe. Therefore, the school's graduation rate for those students is **81** percent.
